D programme on an individual basis. However, for the purpose of award of scholarships, such candidates may have to be treated, initially, as Bachelor's degree holders in engineering, or technology.

2. Regarding admission to Ph. D Programme in the Department of Humanities & Social Sciences, XLRI Diploma holders may be eligible in the area of Psychology, or Industrial Psychology. But, before this can be decided, it is necessary to examine the admission qualifications for the XLRI Diploma as well as curriculum for the Diploma course offered by the XLRI. If, on examination the Institute is satisfied that the contents of the XLRI Diploma course are equivalent for the purpose of admission to the Ph D programme of the Institute in area of Psychology or Indl.
